AN ORDINANCE OF THE HAINES BOROUGH APPROPRIATING \$15,625 DONATED TO THE HAINES VOLUNTEER FIRE DEPARTMENT BY DOROTHY QUINN FOR PURCHASE OF AMBULANCE EQUIPMENT.

BE IT ORDAINED BY THE BOROUGH ASSEMBLY OF HAINES, ALASKA:

Section 1. Classification. This ordinance is a non-code ordinance.

Section 2. Effective Date. This ordinance shall become effective immediately upon adoption.

Section 3. Appropriation. This appropriation is hereby authorized as part of the budget for the fiscal year July 1, 2005 through June 30, 2006.

Section 4. Purpose. To budget \$7,118 towards capital expenses for the new ambulance put into service in June of 2005, \$3,020 for a carbon monoxide monitor, and \$5,487 for an oxygen transfer pump.
