

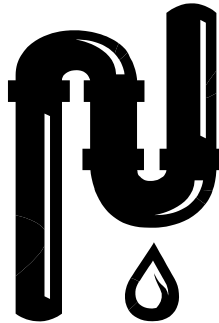

## REQUEST FOR SEALED BIDS

# WATER SYSTEM UPGRADE

## Fourth Avenue, View Street, and Lynnview Drive



Notice is hereby given that the HAINES BOROUGH, Alaska, will receive sealed competitive BIDS from qualified contractors for the following project: "**Fourth Avenue, View Street, and Lynnview Drive Water System Upgrade**," until **2:00 pm**, local prevailing time, Tuesday, **April 26, 2011**, at the Office of the Borough Clerk, Borough Administration Building, 103 Third Ave. S, P.O. Box 1209, Haines, Alaska 99827, at which time and place the BIDS will be publicly opened and read aloud. Bids will not be accepted by email or fax.

**Project Description:** The project consists of furnishing and installing approximately 2,770' of 8-inch AWWA C-900 PVC water pipe and associated fire hydrants, water services and gate valves. It also includes removal of existing asphalt road surfacing, replacing it with a D-1 surface and imported backfill in areas with unsuitable subsurface soils. The work must be completed by September 1, 2011.

Each bid shall be accompanied by a certified or cashier's check or Bid Bond, in the amount of 5% percent of the Total Bid Price payable to the Haines Borough, as a guarantee that the Bidder, if its Bid is accepted, will promptly execute the Agreement. A Bid shall not be considered unless one of the forms of Bidder's security is enclosed with it. All contractors are required to have a current Alaska Contractor's License prior to submitting a bid and current Alaska and Haines Borough Business Licenses prior to award. Bidders shall guarantee the Total Bid Price for 120 calendar days from the date of bid opening.

The Haines Borough reserves the right to reject any or all bids, to waive any informality in a bid, and to make award to the lowest responsive, responsible bidder as it may best serve the interest of the Borough.
