Notice is hereby given that the HAINES BOROUGH, Alaska, will receive sealed competitive BIDS from qualified contractors to perform the **Port Chilkoot Dock Waterfront Improvements** project, until **2:00 p.m.** local prevailing time, **June 15, 2010**, at the Office of the Borough Clerk, Borough Administration Building, 103 Third Ave. S, P.O. Box 1209, Haines, Alaska 99827, at which time the BIDS will be publicly opened and read aloud. Bids will not be accepted by email or fax.

**Project Description:** The project includes a base bid consisting of demolition of an existing timber approach trestle, reconnection of the existing trestle electrical and water system, clearing and grubbing, excavation, removal, disposal and relocation of various structures and signs, placement of shot rock borrow, base course grading, armor rock, geotextile reinforcement, MSE wall, guardrail, handrail, timber curbing, staircases, various concrete structures, storm sewer system, water system, and construction of a public restrooms building, electrical and other improvements. Additive Alternative 1 includes adding dormers to the restroom.

**Pre-Bid Conference:** Prospective Bidders are encouraged to attend a pre-Bid conference of the proposed WORK, which will be conducted by the OWNER, at 2:00 p.m. on June 8<sup>th</sup>, 2010 in the Assembly Chambers, Public Safety Building 213 Haines Highway, Haines, AK. If you wish to participate via teleconference, you will contact the Borough Clerk's Office at (907) 766-2231 at least 72 hours prior to the meeting.

Additional charges will be required for special handling or delivery of the documents by means other than first class mail. Checks should be made payable to the Haines Borough.

Each bid shall be accompanied by a certified or cashier's check or Bid Bond, in the amount of 5 percent of the Total Bid Price payable to the Haines Borough, as a guarantee that the Bidder, if its Bid is accepted, will promptly execute the Agreement. A Bid shall not be considered unless one of the forms of Bidder's security is enclosed with it. All contractors are required to have a current Alaska Contractor's License prior to submitting a bid and current Alaska and Haines Borough Business Licenses prior to award.
